MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (MOU) IS ENTERED ON THIS THE 22nd DAY OF NOVEMBER 2023 BY AND BETWEEN:

M/s. CREDAI CHENNAI [previously known as M/s. CREDAI TAMIL NADU], an association for real estate developers in Chennai, registered under the Tamil Nadu Societies Registration Act, 1975, having one of its offices on 8th Floor, 8E No. 526 (560-562, Century Plaza, Anna Salai, Thiru Vi KaKudiyiruppu, Teynampet, Chennai, Tamil Nadu - 600018, Tamilnadu, INDIA, represented by its Convenor, Skill Development Committee, **Dr. T. ARUL**, hereinafter referred to as the "**CREDAI or First Party**" as which expression shall include its successors, representatives and assigns on the One Part;

AND

SRI VENKATESWARA COLLEGE OF ENGINEERING, SRIPERUMBUDUR, hereinafter referred to as the "**Second Party**", which expression shall include its successors, representatives legal heirs and assigns on the Other Part.

The terms CREDAI/ First Party & Second Party are referred to individually as a "Party" and collectively as "Parties". Both Parties have reached the following intent.

WHEREAS

- 1) CREDAI Chennai is the Chennai chapter of the Confederation of Real Estate Developers' Associations of India, a national organization representing the Indian real estate sector established in the year 2011 with a vision of transforming the landscape of the real estate industry and a mandate to pursue the cause of Housing and Habitat. CREDAI Chennai has grown rapidly over the years with over 189 members. CREDAI Chennai is one of the largest associations of real estate developers in the southern region of India. Its members include some of the most reputed and experienced developers in the city, who are committed to promoting professionalism, transparency, and ethical business practices in the real estate industry.
- 2) CREDAI also facilitates knowledge exchange among its stakeholders through workshops, seminars, conferences, and training programs. These initiatives aim to enhance the professional capabilities of real estate developers and keep them updated with the latest industry trends, technologies, and best practices.
- 3) The Second Party, a unit of Sri Venkateswara Educational and Health Trust (SVEHT) Educational Institutions for a higher learning is functioning under the name of SRI VENKATESWARA COLLEGE OF ENGINEERING.
- 4) The Second Party has requested CREDAI to provide certain technical facilities to their students in the field of civil construction to enable their students to gain practical knowledge and CREDAI has also agreed to provide certain facilities as requested by The Second Party for the benefit of their students;
- 5) The Parties recognize the capabilities and resources of each Party and wish to explore and assess the feasibility of collaborating with each other on the Project as defined in clause 3 below.
- 6) Therefore, the parties have agreed into enter into this MoU in order to reduce the mutually agreed terms & conditions for the above-said purposes into writing being these presents.

NOW THIS MEMORANDUM WITNESSETH AS FOLLOWS

1. OBJECTIVES

The purpose of this MoU is to outline the existing understanding between the Parties regarding their potential cooperation and collaboration on the Project. It aims to facilitate further discussions by:

- (a) Facilitating the confidential sharing of pertinent information between the Parties to identify the respective objectives of each Party pertaining to the Project, as well as assessing the capabilities of each Party to support the achievement of those objectives.

(b) Defining a possible framework, establishing working relationships, outlining the project's structure and implementation, and delineating the future commitments of the Parties in relation to the Project.

2. THE PROJECT

This MoU is intended to establish a framework for collaboration between CREDAI & Second Party in the field of Civil Engineering. The primary objective of this MoU is to facilitate various student training programs, internships, placements, and other activities of mutual interest. The broad terms of this MoU are outlined as follows:

The following facilities set out herein below are hereinafter collectively referred to as the "Project".

2.1. FIELD VISIT PROGRAM

In order to facilitate learning opportunities, the following provisions will be made by the Parties:

The members of CREDAI shall grant access to their work sites for educational purposes. This will allow students to gain practical knowledge and exposure to real-world construction practices.

The Second Party will provide the necessary support and resources to ensure a productive and valuable visit to the work sites. This may include coordinating logistics, arranging transportation, and facilitating communication between the students and CREDAI members.

The members of CREDAI will consider eligible Undergraduate students of 3rd and 4th Semester studying B.E. Civil Engineering program for these site visits. Eligibility criteria, such as academic performance or specific prerequisites, may be mutually agreed upon by both parties.

The safety of the students during the site visits will be a top priority. The Second Party will take the responsibility of monitoring and ensuring the safety of the students throughout the visit. Adequate safety measures and protocols will be implemented by the respective members of CREDAI, and the students will be required to adhere to all safety guidelines and instructions provided by The Second Party.

By establishing these provisions, both parties aim to create a collaborative environment where students can gain practical experience, enhance their understanding of civil engineering practices, and promote a culture of safety in the field.

2.2. INTERNSHIP

CREDAI agrees to consider eligible Undergraduate students of 5th and 6th Semester studying B.E. Civil Engineering program for internships on a paid or non-paid basis, depending on the convenience of CREDAI. The selection of students for internships will be conducted through interviews on a case-by-case basis under the following conditions:

Eligibility: The Second Party will provide CREDAI with a list of eligible students who meet out the required criteria for internships. The specific eligibility criteria, such as academic performance, skillset, or other prerequisites, will be mutually agreed upon by both parties.

Interview Process: The members of CREDAI will conduct interviews with the eligible students of the Second Party to assess their suitability for the internship positions. The interview process will evaluate the student's knowledge, skills, and potential to contribute to the assigned tasks and responsibilities.

Selection: The selection of students for internships will be based on the outcome of the interviews. The members of CREDAI will have the discretion to choose the most suitable candidates for the available internship positions. The final decision regarding the selection of students will be made by the members of CREDAI.

Paid or Non-Paid Basis: The internship positions offered by CREDAI may be either paid or non-paid, depending on the policies and requirements of CREDAI. If applicable, the specific terms and conditions regarding remuneration will be communicated to the selected students before their engagement.

By offering these internship opportunities, CREDAI aims to provide students from the Second Party with valuable industry experience, enhance their practical skills, and offer them exposure to real-world projects and challenges in the field of civil engineering.

2.3. FINAL YEAR STUDENT PROJECTS

CREDAI shall give a mandatory preference to eligible students of the Second Party who are in their 7th & 8th semesters of their final year projects. The selection process will be conducted through interviews on a case-by-case basis under the following conditions:

Eligibility: The Second Party will provide CREDAI with a list of eligible students who meet the necessary criteria for final-year projects. The specific eligibility criteria, such as academic performance, skillset, or other prerequisites, will be mutually agreed upon by both parties.

Interview Process: The members of CREDAI will conduct interviews with the eligible students of the Second Party to evaluate their suitability for the final year projects. The interviews will assess the student's knowledge, skills, and potential to contribute effectively to the assigned projects.

Selection: The selection of students for final-year projects will be based on the outcomes of the interviews. By mandatorily offering preference to eligible students of the Second Party for final-year projects, CREDAI aims to provide them with practical industry experience, promote their skill development, and enable them to work on meaningful projects under the guidance of experienced professionals.

2.4. EVENTS

2.5. AWARDS

CREDAI agrees to establish the "Best Outgoing Civil Engineering Student Award" to recognize and encourage outstanding students in the field of civil engineering under the following terms and conditions:

Annual Award: Annual Award: The award will be given annually to three deserving students of the Second Party who have showcased outstanding academic performance, leadership qualities, and overall excellence in the field of civil engineering. The award amounts will be as follows:

- a) The first outstanding student will be awarded a sum of Rs. 25,000/-.
- b) The second outstanding student will be awarded a sum of Rs.15,000/-.
- c) The third outstanding student will be awarded a sum of Rs. 10,000/-.

In addition to the award amounts, the members of the CREDAI will bear the expenses associated with the award.

Certificate of Recognition: The award shall include a certificate jointly issued by CREDAI and the Second Party, acknowledging the student's achievements and contributions. The certificate will bear the official seals and signatures of both parties, representing their endorsement and recognition.

2.8 MATERIAL TESTING SERVICES

- c. Aggregate Testing: This includes testing the properties of aggregates used in construction, such as particle size distribution, impact value, crushing value, abrasion resistance, and specific gravity.
- d. Steel Testing: This includes testing the mechanical properties of steel used in construction, such as tensile strength, yield strength, and elongation.
- e. Brick and Block Testing: This includes testing the compressive strength, water absorption, and dimensions of bricks and blocks used in construction.
- f. Timber Testing: Timber testing involves evaluating the strength, density, moisture content, and durability of timber used in construction.
- g. Geotechnical Testing: Geotechnical testing includes testing the properties of soil and rock formations, such as permeability, bearing capacity, and consolidation characteristics.

The Parties acknowledge and agree that the Areas of Collaboration are not exhaustive in nature and the Parties shall in good faith, negotiate to elaborate upon the Areas of Collaboration, including additional areas of collaboration as may be mutually agreed in writing, and the rights, responsibilities, and obligations of each Party in relation to each of the Areas of Collaboration. The Parties may, from time to time, execute addenda or modifications to this MOU to incorporate such additional scope of collaboration or discussions as per the need.

4. USE OF BRANDING, LOGOS & TRADEMARKS

Both parties shall use the trademarks, logos, trade names, service marks, or other proprietary marks of the other Party to this MOU in any advertising, press releases, publicity matters, or other promotional materials with prior approval of the other Party in writing. The parties agree and recognize that the right to use the same in no manner amounts to any assignment or transfer of ownership of the trademarks, logos, trade names, service marks, or other

proprietary marks. The parties further agree that the use of the Intellectual Property will not extend beyond the scope of the present MOU.

5. TERM OF MOU AND TERMINATION

The term of this MOU will be effective for one year from the date of signing unless mutually extended by the parties in writing, and either party can terminate it by giving the other party a written notice of at least 3 months.

6. TERMS

6.1 Costs and Expenses

The Second Party shall be responsible for meeting their own expenses in connection with all matters related to MOU.

6.2 Assignment

Neither of the Parties shall assign any of their duties under this MOU to any other person or institution without prior written approval of the other party.

6.3 Amendments

No alterations, additions, or modifications hereto shall be valid and binding unless the same is reduced to writing and signed by both Parties.

6.4 Non-Exclusive Discussions

The Parties acknowledge and agree that the Areas of Collaboration under this MOU are being undertaken on a non-exclusive basis and either Party shall be free to enter or consummate transactions like the Areas of Collaboration with other parties in India or elsewhere.


6.5 Confidentiality and Public Announcement:

"Confidential Information" means and implies any or all information, which includes but is not limited to the confidential, proprietary, and trade secret information of the disclosing party to be disclosed by the disclosing party under this MOU, and comprises (a) information in a tangible form that: (a) (1) bears a Confidentiality Legend, or (2) does not bear any Confidentiality Legend, if the receiving party knew, or reasonably should have known under the circumstances, that the information was confidential and had been communicated to it in confidence, and (b) discussions about that information that may occur before, at the same time, or after disclosure of the information disclosed directly or indirectly and in any form whatsoever (including, but not limited to, the disclosure made in writing, oral or in the form of samples, models, computer programs, hard copy, soft copy or any human readable form, drawings or other instruments). This MOU and all confidential information exchanged between the Parties pursuant to this MOU shall be held in confidence.

Either Party may use the Other Party's logo on its website with a link to the Other Party's website on the execution of this MOU with prior approval in writing.

Neither Party nor any of the affiliates shall make any public announcement about the MOU and /or the scope of the proposed engagement, without the prior written consent of the other

Party. Any public announcement so made shall be as per a mutually agreed format.

6.6 License and Intellectual Property Rights

No license or sub-license is granted under this MOU to either Party under any of the other Party's intellectual property rights, either expressly, by implication, inducement, estoppel, or otherwise. Both Parties understand and acknowledge that the grant of any such license shall always be expressed and in writing. CREDAI will not be responsible for any breach of the Intellectual Property of the Second Party. Similarly, the Second Party will not be responsible for any breach of the Intellectual Property of CREDAI.

6.7 Conflict of Interest

Neither of the parties believes that the Collaboration contemplated by this MOU raises any actual or potential conflicts of interest. The parties agree that this MOU and the negotiation of the same (and any other agreements entered in connection herewith) are independent of any past, present, or potential future arrangements, and are not connected to an existing business relationship between either of the parties.

7. DISPUTE SETTLEMENT

This MOU shall be governed by and construed in accordance with the laws of the Republic of India. All disputes arising out of or related to this MOU, including without limitation all matters connected with its performance, will be governed by, construed, and interpreted under the laws of India, without reference to conflict of laws principles.

All disputes and differences arising out of or in connection with this MOU shall be the first instance referred to arbitration by three (3) arbitrators, jointly appointed by Parties. The decision and award determined by such arbitration will be final and binding upon the Parties. The arbitration will be conducted in accordance with the Arbitration and Conciliation Act, 1996, as may be in force from time to time. The arbitration proceedings will be conducted in English and the seat of arbitration will be Chennai.

This MoU shall be governed by Indian law and the parties hereto submit themselves to the exclusive jurisdiction of the courts in Chennai.

8. NOTICES


